

# *CNY Virtual 2021*

## RULES & REGULATIONS

### **OBJECTIVES**

This Tournament is organized and hosted by Civil Service Club for all local bowlers to foster and promote goodwill, comradeship, friendship and sportsmanship amongst the bowling fraternity.

**CNY Virtual Tournament will be held from 1<sup>st</sup> February to 28<sup>th</sup> February 2021**

### **ELIGIBILITY**

CNY Virtual is open to all bowlers except present National Bowlers.

### **PLAYING RULES**

Singapore Bowling Federation playing rules will apply.

### **FORMAT OF PLAY**

The qualifying scores will be based on the best attempt at three (3) Civil Services Club Bowling Centers, namely, Resort Bowl, Planet Bowl and Westwood Bowl.

One (1) best attempt x 3 centers = total of 12 games) to be placed in the leaderboard ranking. Each attempt consists of a 4 games series, played on open lanes (no cross lane) with three (3) minutes practice time per bowler.

Bowlers will have to attempt at least once at all three Civil Service Club bowling centers, Best attempt scores from all 3 centers will determine the 12 games series leaderboard ranking. Bowlers will have unlimited tries to obtain the best attempt at each center, during the duration of the qualifiers from 1<sup>st</sup> February – 28<sup>th</sup> February 2021.

### **MQ's SCORES**

Manual Adjustment to scores by bowlers are not allowed unless verified by counter staff.

Un-verified scores adjustment detected through Brunswick score sheet would invalidate their MQ's scores.

### **ENTRIES FEE**

All entries must be submitted on prescribed forms provided.

One Time Registration Fee : \$18.00

#### **1<sup>st</sup> February 2021 to 25<sup>th</sup> February 2021**

Qualifying Entry Fee (Non Peak) : \$18.00 per entry - 4 games series

Qualifying Entry Fee (Peak) : \$28.00 per entry - 4 games series

#### **26<sup>th</sup> February 2021 to 28<sup>th</sup> February 2021**

Qualifying Entry Fee (Last 3 Days) : \$38.00 per entry - 4 games series

### **HANDICAPS**

Ladies : 8 pins per game.

Senior Citizen ( Age 60 & above ) : 8 pins per game.

Senior Citizen ( Age 50 & above ) : 5 pins per game.

Juniors ( Age 16 and below as of 28<sup>th</sup> February 2021 ) : 5 pins per game.

**OILING PATTERN**

Bowling Centers House Oiling applies.

**REFUNDS**

No refund of entry fees will be made after it has been paid and the entry has been accepted and registered.

**AWARDS**

Perfect Game and House Awards do not apply throughout the Tournament.

**VERIFICATION OF SCORES**

It is the responsibility of each bowler to verify the correctness of each game bowled by signing on the official result sheet which will be used as the official score recorded. Once signed, the scores shall stand, unless otherwise decided by Tournament Manager. In the event, the official score sheet is not signed, for any reason, the Tournament Manager reserves the right to refuse acceptance of the result sheet.

**TIE BREAKER**

Should a tie occur, the tiebreaker shall be based on the least difference between the highest and lowest games bowled...Should the least difference between the highest and lowest games be still tied, the high game will decide the position standing.

**PROTESTS**

Eligibility – Protest involving eligibility must be submitted in writing to the Tournament Director/Manager or his appointed official on duty within 24 hours of the time of the alleged infringement.

**SCORING ERRORS**

Errors in scoring or errors in calculation will be corrected by the Tournament Officials immediately upon discovery of such errors. Protests involving errors in scoring will only be entertained if such protests are brought to the attention of the Tournament Manager or his appointed official on duty on the spot.

**FOULS**

Protest involving fouls must be brought to the attention of the Lane Marshall before the delivery of the next ball. No protest will be entertained after the bowler has made his/her second delivery of the frame and will not be entertained after the presentation of prizes.

**INTERPRETATION CLAUSE**

The Tournament Director or, in his absence, his appointed official on duty reserves the right to accept or reject any entry(ies) as he/she deems fit. Any matter arising which is not covered in these Tournament Rules & Regulations will be decided by the Tournament Manager whose decision shall be final.
