RULES & REGULATIONS

1 ELIGIBILITY

- 1.1 The Competition is open to all civil servants and officers serving in Statutory Boards, Restructured Hospitals, Government-Aided Schools and registered former Statutory Boards, and members of the Civil Service Club.
- 1.2 Participants must be 16 years old and above as of 1st January 2026.
- 1.3 Tournament Platform
 - This tournament will be played online on the Mobile phone.
 - Players will be required to have an MLBB account that fulfills the following criteria
 - Level 8 or above
 - Owns at least 10 heroes

2 ENTRY & REGISTRATION OF PLAYERS

- 2.1 Registration can be submitted through the Sports Liaison Officer of the Ministry/organisation.
- 2.2 Registration must be accompanied by **online payment of registration fee** otherwise, it will be void. There shall be no refund of registration fees.
- 2.3 E-Sports Convenors from the respective agencies would be the designated administrator for the tournament and must ensure that the team participates on the event day.
- 2.4 Convenors must ensure that the mobile phone numbers of each registered participant/s must belong to the registered participant and not belong to another person.
- 2.5 **Registration Requirements:**
 - This tournament is only open to players based in Singapore

3 FORMAT

- 3.1 The Competition is for teams based on **Single Elimination, best of 3.**

4 **PLAYER REPORTING**

4.1 **Communications**

- All information and communication will be **sent via email to the team captain.**
- All tournament management and reporting will happen on site at the event venue stated above.

4.2 **Pre-Game Reporting**

- Players should report to venue **at least 30 minutes** before the event start time.
- Players who are late will be disqualified.

4.3 **Post-Match Reporting**

- All teams are required to show the end-game match scores at the end of every match to the on site referee for verification of scores.
- Any teams whom have failed to report matches will be subject to confirmation from both teams and disputes will be resolved accordingly.

5 **TOURNAMENT SETTINGS**

5.1 Players will be required to set up their own matches after tournament admins have briefed them.

5.2 **Tournament rules**

- Tournament will be played in-person.
- Tablets are allowed.
- No emulator and third-party programs/peripherals allowed.

5.2 The Match Settings are as follow:

- Custom brawl mode

6 PRIZES

- 6.1 Prizes will be awarded to the top 4 teams in the tournament as follows:
- a) Champion: Cash Prize \$350, Champion Trophy and 5 Medals
 - b) 1st Runner-up: Cash Prize \$300 and 5 Medals
 - c) 2nd Runner-up: Cash Prize \$250 and 5 Medals
 - d) 3rd Runner-up: Cash Prize \$200 and 5 Medals
